### **Preliminary Notification**

Whereas it appears to the district Collector, Guntur District and appropriate Government (as notified under the proviso of section 3(e) of the Act, read with Rule 2(1) (b) of the APRFCT in LA, R&R Rules, 2014) that the land/ Structures/trees specified in the scheduled below of Guntur Village, Guntur Mandal, Guntur District as requisitioned by the Dy. Chief Engineer (Construction) South Central Railways, Guntur are needed for a public purpose, to wit, for 'Doubling with Electrification of Guntur-Tenali Section, notice to that effect is hereby given to all to whom it may concern in accordance with the Provisions of Section 11(1) of the Right To Fair Compensation and Transparency in Land Acquisition Rehabilitation and Resettlement, Act,2013 (Central Act-30 of 2013).

Social Impact study was carried out by the Revenue Divisional Officer, Guntur with the prescribed team members and report submitted that bi families are likely to be displaced due to this land acquisition.

The Joint Collector is appointed as Project Administrator vide notification issued in G.O.Ms.No.1 Revenue (LA) Dept. dated 02.01.2015 U/s 43(1) of the Act for the purpose of Rehabilitation and Resettlement of the affected families.

Now, therefore, in exercise of the powers conferred under section 3(e) of the Act, read with Rule 2(1) (b) and 3(g), the District Collector Guntur hereby, designates the Revenue Divisional Officer, Guntur, his staff and work men to exercise the powers of the Collector conferred under the Act.

The District Collector hereby authorizes the Land Acquisition Officer to conduct survey under Section 12 and 20 of the Act, and the owners of the lands are informed to be present in person or through authorized representative while conducting Survey within 60 days from the date of this

notification failing which survey would be conducted in the absence of the owner.

As mentioned under Section 11(4) of the Act, no person shall make any transaction or cause any transaction of land i.e., sale/purchase etc., or create any encumbrances on such land from the date of this notification without prior approval of the Collector.

Objections to the acquisition, if any, may be filed by the persons(s) interested within 60 days from the date of publication of this notification as provided under section 15(1) of the Act in respect of area suitability of land and justification offered for the public purpose before the Land Acquisition Officer and objections if any received in time will be enquired on 17.05.2017 by 11.00 A.M in the office of the Revenue Divisional officer, Guntur.
